BILINGUAL PROJECT IS  
FUNDED FOR 1982-83

EMU's Bilingual Vocational Education Instructor Training Project, one of two such programs funded this year in the nation, has had its funding renewed for 1982-83 with a \$154,000 award from the U.S. Office of Bilingual Education and Minority Languages Affairs.

The purpose of the EMU project is to recruit bilingual persons with technical skills in a trade or industrial occupation and provide them with course work leading to a bachelor's degree and certification as Michigan vocational teachers. The project actively recruits Arabic/Chaldeans, Hispanic and Vietnamese bilingual candidates who have two or more years of preparation in a trade or industrial occupation.

The EMU project offers a six-week summer institute and courses during the fall, winter and spring semesters. Up to 100 percent tuition reimbursement and stipends are available to participants to assist with personal expenses.

Funding for the program is provided by the Federal Department of Education as a response to Public Law 94-482 which legislated the expansion of enrollment opportunities for persons of limited English-speaking ability in vocational programs.

The goal of the EMU project is to recruit and train 20 new candidates from the Arabic, Spanish and Vietnamese populations in Michigan. Students currently enrolled in the program include Arabic, Spanish and Vietnamese individuals from Saginaw, Flint, Lansing, Muskegon, Port Huron, Detroit, Dearborn and Ypsilanti.

TEACHERS TO GET GRANT FOR  
ENROLLING IN EMU COURSE

The first 25 teachers who enroll in an economic education program offered Aug. 9 through 13 at the Michigan Consumer Education Center at EMU will be eligible for a \$60 tuition grant.

The program, offered for two hours of graduate credit, is sponsored in conjunction with the Joint Council on Economic Education. The course will include viewing two new film series: "Trade Offs" and "Give and Take." Both series have been designed to expand economic and consumer education.

The course will meet from 9 a.m. to 4 p.m. in Room 214 of the EMU Library.

Jan Lloyd, co-director of the Michigan Consumer Education Center, will be the course instructor. Robert Ristau, professor of business education and coordinator of the new "Give and Take Program," will assist her.

Costs of the course are being underwritten by the Joint Council on Economic Education with tuition grants provided by the Association of Michigan Economic Education Centers.
