The Office of Research Development and Administration is soliciting applications for the 6th cohort of the EMU Culture of Research Excellence (CoRE) Grant Writing Program, starting Winter 2021. The CoRE program is for faculty who are ready to write a proposal and would like support during the process in order to produce a highly competitive application. To maximize the benefit of this program, eligible faculty participants should be ready to begin the development of a competitive proposal for federal funding.

Evidence of readiness may include one or more of the following:

- · Clear research idea with relevance for program within a specific directorate or institute
- · Prior submission of federal research funding· Prior non-federal funding· Preliminary data in hand
- Relevant research publications
- · Effective collaboration established (if applicable)

National Institutes of Health, Tobacco Control Policies to Promote Health Equity (R21, Clinical Trial Optional)

The purpose of this Funding Opportunity Announcement (FOA) is to support observational or intervention research focused on reducing disparities in tobacco use and secondhand smoke (SHS) exposure in the U.S. Specifically, this FOA aims to stimulate scientific inquiry focused on innovative state and local level tobacco prevention and control policies. The long-term goal of this FOA is to reduce disparities in tobacco-related cancers, and in doing so, to promote health equity among all populations.

National Science Foundation/National Endowment for the Humanities, Documenting Endangered Languages

This funding partnership between the National Science Foundation (NSF) and the National Endowment for the Humanities (NEH) supports projects to develop and advance knowledge concerning dynamic language infrastructure in the context of endangered human languages—languages that are both understudied and at risk of falling out of use. Made urgent by the imminent loss of roughly half of the approximately 7,000 currently used languages, this effort aims to exploit advances in human-language technology to build computational infrastructure for endangered language research. The program supports projects that contribute to data management and archiving, and to the development of the next generation of researchers. Funding can support fieldwork and other activities relevant to the digital recording, documentation and analysis, and archiving of endangered language data, including the preparation of lexicons, grammars, text samples, and databases. Funding will be available in the form of one- to three-year senior research grants and conference proposals. Fellowship support will remain available but will be administered by NEH.
