Official minutes of the Board of Regents' meeting of February 29, 1984

Chairman Robb called the meeting to order at 11:10 a.m.

Chairman Robb called for the report from the Student Affairs Committee stating that after this report a quorum should be present.

Vice President Smith gave the Student Affairs Committee report, due to the absence of Regent Ellington the chairperson. He reported this committee met on February 9, 1984, and reviewed some of the subjects discussed.

.2843 M COMMENDATION: MEN'S SPRINT RELAY TEAM

Regent Board moved and Regent Milford seconded the Commendation for the Men's Sprint Relay Team.

- WHEREAS, the Men's Sprint Medley Relay Team ran a three-minute, 18.7 second clocking in the Western Michigan Relays Friday, January 28, 1984; and
- WHEREAS, Michael Calhoun, a junior from Shaker Heights, Ohio, ran an opening 400-meter leg in 47.7 seconds, Darron Witherspoon, a freshman from Detroit, ran his 200-meter leg in 21.9 seconds, Daryl Curry, a junior from Akron, Ohio, ran his 200-meter split in 21.5 seconds, and Earl Jones, sophomore from Taylor, ran the 800-meter anchor leg in one minute, 47.6 seconds; and
- WHEREAS, this outstanding effort set a new world's record in the event, formerly held by Michigan State University with a time of 3 minutes, 22.67 seconds; and
- WHEREAS, this effort also broke a record of three minutes, 20.8 seconds held by the University of Michigan but not considered a world's record because not all runners on that team were from the same country;
- NOW, THEREFORE, BE IT RESOLVED, that the Eastern Michigan University Board of Regents does congratulate the Men's Sprint Medley Relay Team and head track coach Robert Parks for the honor and distinction they have brought themselves and their University.

As a stopgap, checks are deposited manually in a limited number of banks by the Payroll Office on special request. Approximately 500 of the 1,800 university employees do avail themselves of this manual service.

The University is moving with some urgency to complete installation of a computer system improvement which will allow automatic deposit of paychecks via magnetic tape in any banking institution having access to federal wire transfer facilities. This improvement will greatly expand upon services presently available to employees and will simplify current payroll procedures. Based on current acceptance of the manual service, we expect the majority of the employees will avail themselves of the automatic service. It is hoped that the new system can be installed yet this fiscal year.

To complement the automatic deposit of paychecks, the employees have expressed considerable interest in having electronic banking terminals on campus. One local bank - Ypsilanti Savings Bank - does presently have a terminal in McKenny Union. The University has been approached by other local banks who have interest in installing additional terminals.

The administration plans to allow installation of banking terminals by local banks with whom a significant number of employees have accounts, as evidenced by the automatic payroll deposit, and who agree to finance and maintain those terminals at bank expense. Based on present employee practices and expressed interest by banking institutions, it seems logical to expect the likelihood of terminal installation in the foreseeable future by the following four banks:

.2860 M DEFERRED MAINTENANCE -- Governor's Commission

Regent Simmons moved and Regent Board seconded the recommendation regarding the Governor's Commission on the Future of Higher Education, that the Board of Regents receive and place on file the materials which describe one area of concern, deferred maintenance; which has come to the attention of the Governor's Commission on the Future of Higher Education.

President Porter was asked to elaborate on this report in more detail.

Motion carried.

.2861 M QUIRK THEATRE FUND RAISING CAMPAIGN -- Report

Regent Simmons moved and Regent Board seconded the report on the Quirk Theatre Fund Raising Campaign be received and placed on file.

QUIRK/SPONBERG REPORT

Eastern Michigan University's first capital campaign appears to be on target toward its goal of raising \$1.1 million prior to December 31, 1984. The success of this campaign will allow the University to construct a new 200 seat Sponberg Theatre and renovate the current Quirk Theatre complex by adding a scenery shop, a costume shop, and relocating the lobby to make it adjacent to existing University parking and accessible to the handicapped.

The University has raised a total of \$760,360 as of December 31, 1983, mostly in large gifts. Included in the large gift category are gifts from The Kresge Foundation, The Mott Foundation, The Herrick Foundation, Mrs. Margaret Cameron and the original \$150,000 challenge gift from an anonymous source.

The University is currently conducting seven fund raising efforts that are expected to raise \$184,500 during winter and spring, leaving the campaign just \$156,000 short of its eventual target.

Chairman Robb asked President Porter to elaborate on the recommendation to transfer Jim Brunnemer from Alumni Director to Director of Development.

President Porter noted that the University has a very critical situation as there has to be some leadership in the Development Office, and it was his belief that Dr. Brunnemer was the best candidate to do that job. As the two searches for a Director of Development was unsuccessful, he thought this move from Alumni Director to the Director of Development would be beneficial. Also, a national search will begin immediately to find a replacement for the Alumni Director.

.2862 M DIRECTOR OF DEVELOPMENT

Regent Board moved and Regent Simmons seconded that Dr. James Brunnemer be appointed the Director of Development (AP-11) at an annual salary of \$40,000, effective March 1, 1984.

Motion carried.

.2863 M ANALYSIS OF NEW & RETURNING STUDENTS - Report

Chairman Robb asked President Porter to make the report on the Analysis of New and Returning Students. Regent Board moved and Regent Simmons seconded the report be received and placed on file.

Motion carried.

Vice President Smith noted that March 28 is Founders Day on campus and asked if the Regents could attend the cake cutting ceremony.

Regent Board announced the MAGB Awards Ceremony will be held April 11, at the Kellogg Center in Lansing.

Meeting adjourned at 4:00 p.m. Next meeting is scheduled for March 28, 1984.
