## Summer enrollment up in all categories

Summer enrollment at EMU is up from last year's figures in every category. The figures were compiled as of the one-tenth reporting date (July 5) and show that total enrollment increased from 4,339 in 1984 to 4,661 this summer, an increase of 322 students or seven percent.

When that total increase is broken down into undergraduate and graduate figures, the jump is seven percent on both counts. Undergraduate enrollment increased from 2,784 to 2,989, a jump of 205 students. The number of graduate students increased by 117 students, from 1,555 to 1,672.

For undergraduates, the largest increase came in the new students category. Undergraduates attending EMU for the first time increased by 110, from 128 to

238, an 85 percent increase. Returning student enrollment jumped three percent, from 2,656 to 2,751.

Unlike EMU's spring session, when enrollment was up but total credit hour production was slightly down, the number of credit hours produced this summer has increased from 1984 by 1,066. That represents a 54 percent increase. The bulk of that increase—970 credit hours— were produced at the undergraduate level while graduate students accounted for the remaining 96. Undergraduate credit hours went from 12,623 to 13,593, a seven percent jump. Graduate credit hours increased by 12 percent from 5,795 to 5,891.

A total of 1,949 males and 2,712 females are enrolled this session.

## Interim appointments made in Human Resources

Three interim appointments in the Human Resources Office have been announced by Acting Executive Director Robert Stone.

Melonie B. Colaianne, assistant director of Staff and Union Relations, has been appointed acting director of Affirmative Action and Employment. Helen M. Burnstad, staff training and development associate, was appointed acting director of Staff Training and Development. Jacqueline Wiley, Human Resources data specialist, was appointed acting employment manager.

The appointments of Colaianne and Wiley reflect a reorganization of the Affirmative Action and Employment functions in the Human Resources Office necessitated by the resignations of James P. Greene, executive director of Human Resources and chief Affirmative Action officer, and Helen A. Perri, employment programs associate. Burnstad is replacing Kenneth Handwerger who left the University for a position in private business.

National searches for the two directors' positions will begin shortly.

Colaianne has been employed here

since 1976. She served first as a secretary in the Personnel Office and was appointed a personnel representative in 1980. From 1981 to 1983, she served as compensation programs associate and benefits manager and was appointed assistant director of staff and union relations in 1984.

As acting director of Affirmative Action and Employment, Colaianne will be responsible for monitoring and coordinating all aspects of the University's recruitment and employment programs.

Burnstad was appointed staff training and development associate at EMU in 1984. Previously, she had served as an instructor of speech and public communication at Nebraska Western College, administrative assistant at the University of Arkansas, and as an English and speech teacher in Lander, Wyo., Laramie, Wyo., and Bridgeport, Neb.

As acting director of Staff Training and Development, Burnstad will be responsible for planning, developing and coordinating all executive, faculty, administrative/professional,

## EMU again hosts Institute for Talented and Gifted

More than 100 talented and gifted high school students from throughout Michigan will have an opportunity to hear Broadway and film star Jeff Daniels and civil rights activist Rosa Parks at the Michigan State Board of Education Summer Institute for the Arts and Sciences, scheduled here though Saturday, July 27.

This is EMU's second year as host of the Summer Institute, which is a twoweek residential program for highlytalented 11th grade students who were selected by their schools or intermediate school districts because of their abilities and interests.

Eastern is one of five universities participating in the Summer Institute and is focusing on communication, politics and the law.

During their two weeks here, participants will select from a series of intensive courses primarily taught by EMU faculty including the Civil Rights Movement, law, conflicts in society, interpersonal communications, and theatrical performance techniques. In addition, students may participate in a simulated society game or a video workshop. Exploratory sessions will be offered in a variety of disciplines to round out the educational experience.

All of the Summer Institutes are funded primarily by the Michigan State Board of Education. This year, EMU received a \$50,000 grant from the state to support the Institute.

Other sites selected to host the 1985 Summer Institutes were Central Michigan University, Grand Valley State College, Northern Michigan University and Saginaw Valley State College.

State Supreme Court Justice James Brickley will address the students Wednesday, July 24, at 8 p.m. in the Intermedia Gallery and State Representative Lana Pollack will speak Thursday, July 25, at 9 a.m. in the Snack Bar in McKenny.

Civil rights activist Rosa Parks will speak here Thursday, July 25, at 1 p.m. in the Snack Bar in McKenney.

In addition, a panel discussion on Women in Political Careers is scheduled for Tuesday, July 23, at 8 p.m. in the Intermedia Gallery. Dr. Marjorie Lansing, professor of political science here, will serve as panel facilitator. The panel will include State Representative Maxine Berman; Becky McGowan, campaign manager for Mondale/Ferraro; Sallyanne Paton, professor of law at the University of Michigan; and Sarah Power, University of Michigan Regent.

Although the speeches and panel discussion are not open to the public, interested members of the University community are welcome to attend.

# Anderson named to State post

Dr. John E. Anderson, associate professor of economics here, has been appointed Deputy Treasurer of Tax and Economic Policy for the State of Michigan. He will take a one-year leave of absence from the University in order to serve the state.

As one of two deputy treasurers, Anderson will advise State Treasurer Robert Bowman and Governor James Blanchard on issues concerning tax policy. He will assume the post no later than Aug. I.

Anderson, 34, joined the faculty in 1971. He earned a Bachelor of Arts degree from Western Michigan University in 1973. Before moving on to Claremont Graduate School in Claremont, Calif., Anderson worked as a city planner for Kalamazoo, Mich. for one summer. Anderson developed a keen interest in urban economic during that time and focused on that subject while earning both master's and doctoral degrees from Claremont. He also lectured on economic statistics at Claremont and Harvey Mudd College before coming to FMU.

Anderson is widely published in economic journals. His research activities have covered many topics, all related to urban economics. While at Claremont he developed a computer model that predicted housing prices in Southern California. In other research projects he looked at Michigan property taxes and studied what affects them. He also analyzed how tax incentives for business can affect homeowners' tax rates and urban development and how population density relates to the economic situation of certain areas.

#### **EMU offers swimming lessons**

There are still openings in the Summer Youth Instructional Swimming Program which began July 15 and runs through Aug. 1 in Warner Club Pool.

The program is for children ages 5-12. Children will be pre-tested and placed according to their abilities, into one of four categories: "Guppies" (beginners), "Tadpoles" (advanced beginners), "Minnows" (intermediate) and "Fish" (advanced). Each class spends 45 minutes in the pool daily, with Fish starting at 8 a.m., Minnows at 9 a.m., Tadpoles at 10 a.m. and Guppies at 11 a.m.
